### Job Summary:

A Dive Technician (Electrical) is regarded as someone who is conversant with the electrical systems of diving equipment associated with subsea marine operations.

They can participate in the Dive Technical Team during operations and will report directly to the Dive Technician Supervisor when offshore.

The Dive Technician (Electrical) is expected to take part in the competence assessment process.

### Entry Level Specifications:

- Prior detailed knowledge, skills and experience of electrical/electronic engineering gained through one of the following:
- Trade qualification or Advanced academic education or Military training/qualification or Extensive experience in previous employment
- Current and valid survival certificate
- Current and valid medical certificate
- Complete employing company familiarisation course

### Competencies:

- 1) The ability to perform activities in a safe manner in accordance with legislative and operating company requirements
- 2) The ability to participate in emergency procedures as required on the vessel or installation where operations take place
- 3) The ability to perform in a team and co-operate in all operational activities in a safe and reliable manner
- 4) The ability to fully understand the dive system chamber configuration and the ancillary equipment required to maintain the correct environment for a diver's wellbeing
- 5) The ability to undertake planned maintenance and fault finding activities on industry standard divers' hats
- 6) The ability to store, maintain and conduct electrical umbilical re-terminations
- 7) The ability to undertake all routine administrative tasks that are required to be undertaken during normal dive maintenance operations
