### Job Summary:

A Senior Subsea Asset Supervisor is regarded as someone who is fully conversant with the technical system requirements of diving equipment associated with subsea marine operations.

They can supervise and lead the Dive Technical Team during operations and will report directly to the Offshore Project Manager/Dive Superintendent when offshore.

The Senior Subsea Asset Supervisor is expected to take part in the competence assessment process. As well as assess and coach/mentor, Subsea Asset Technicians and Senior Subsea Asset Technicians.

### Entry Level Specifications:

- Prior knowledge, skills and experience of electrical/electronic OR mechanical/hydraulic engineering gained through either: Trade qualification or Advanced academic education or Military training/qualification or Extensive experience in previous employment
- Completion of Subsea Asset Supervisor competences either electrical or mechanical
- Current and valid survival certificate
- Current and valid medical certificate
- Complete employing company familiarisation course

### Competencies:

- 1) The ability to implement and supervise company safety management systems in accordance with legislative and operating company requirements
- 2) The ability to manage the Dive Technical Team during emergency procedures as required on the vessel or installation where operations take place
- 3) The ability to supervise a team during all operational activities in a safe and reliable manner
- 4) The ability to implement effective management techniques in the workplace
- 5) The ability to liaise with both site and shore based client and company personnel (as appropriate)
- 6) The ability to understand and implement company management systems in the workplace
